We are the controller and the processor of your data. We will use your information as defined in this Privacy Policy.

Your Data Collection

We do not collect data from third parties. We only use data given to us by you via phone, email, fax or via our website or gathered from public domain.



We only collect data needed to provide our customers with the products and services that they require and in order for us to supply the service and product requested. We may at some points send emails for marketing purposes.

This includes:

- Company names
- Employee names
- Employees business title
- Business addresses
- email addresses
- phone numbers
- fax numbers
- Company registration number
- Company Vat Registration number

All of which are provided by you the customer/business in writing or via phone.

The above details are kept on our CRM system – HubSpot. Only key information will be kept as this will help Turbo Controls Ltd establish the data needed to best help with Customers enquires.

We will collect additional information from customers who apply for and/or obtain credit accounts including

- Bank account details
- Your credit history and other financial information either via credit searches you have authorised or provided as part of your application. Your company registration number is used on Atradius our Credit Insurers Portal to obtain your financial credit worthiness and if credit Insurance can be obtained for you to have a credit account with us this information will be stored by Atradius too. The above details are kept on our accounting – Xero, and Stock control – Unleashed, systems. Whenever your account is used we will collect transactional information regarding goods purchased, your payment terms, date and time of purchase and your company details as set out above and should you require special requirements these are documented on our systems. How do we use your Data.

We process your data so that we can provide you with goods and services. These processes include:

Managing & maintaining your account:

- Considering an application for credit.

Who we share your Data with?

How we use the information you provide us with?

We collect and use your information in the following circumstances:
